

House Rules and Regulations of District 5

Havlíčková 292/1, 500 02 Hradec Králové

By entering the premises, the customer is guided by the individual points of the rules. These operating rules define the principles of behaviour of the bar's customers, their rights and obligations. Violation of these operating rules is a ground for punishment according to the rules or a ban on entry.

The premises of the bar (premises) intended for customers consist of: the main entrance, the corridor, the lounge, the main hall with a tap and a bar, men's and women's restrooms.

The proprietor shall be responsible for the operation of the premises and shall have the right to check compliance with the rules set out in these regulations and to take appropriate action.

These rules are obligatory for all customers using the premises.

Rights and obligations not expressly regulated or specified in these rules shall be determined by other internal regulations and the relevant dispositions of the applicable legislation, in particular the legislation governing health and safety.

The proprietor reserves the right to evict visitors from the premises in case of inappropriate behaviour and violation of any of the following points listed in the rules, without refunding the price of drinks and food in the event that the visitor has already paid for them.

The proprietor reserves the right to permanently or temporarily prohibit the entry of persons who repeatedly provoke a conflict in the premises.

The proprietor reserves the right to get a compensation for damage to the equipment of the establishment (glassware, china and other small items) at a uniform price of CZK 50 per piece. In case of intentional damage or vandalism of property or equipment of higher value, the customer is obliged to pay the full price of the damage according to the extent of the damage (this also applies to board games).

The proprietor reserves the right to refuse entry to the premises if the customer is inappropriately dressed (soiled clothing, torn, smelly, etc.), drunk, under the influence of drugs or other addictive substances.

Smoking of tobacco products is prohibited in all indoor areas of the establishment, except for hookah and electronic cigarettes (these are only allowed in the main hall).

It is forbidden to bring and use pyrotechnics, explosives and to handle with open flames.

Weapons must not be brought into the premises.

No beverages, food and their subsequent consumption on the premises.

The proprietor shall not be liable for items left loose on the premises, or for their loss, damage or destruction.

It is not permitted to sell or serve alcoholic beverages, even in closed containers, to persons under the age of 18 years of age, to persons who, if in doubt, cannot prove on their ID that they are over 18 years of age, to persons intoxicated, as well as to offer, provide or otherwise facilitate the use of tobacco products by such persons.

The operator reserves the right not to allow persons under the age of 18 to attend certain pre-announced events.

Customers are obliged to observe the opening hours indicated on the entrance door to the premises. The operator reserves the right to adjust the operating hours without prior notice.

The customer is obliged to follow the instructions of the staff.

Customers are not allowed to borrow the exhibited board games themselves without a prior consultation with the bar staff.

The rental fee for the games is subject to the current price list stated in the menu.

No loose animals are allowed on the premises, animals on a leash are permitted. In the event that any present customer requests the animal to be evicted from the premises or otherwise expresses his/her disapproval of its presence, the staff is authorized to evict the animal from the premises.

The parents themselves or an adult accompanying the children shall be responsible for the supervision of children on the premises. If the behaviour of children repeatedly disturbs the peaceful flow in the bar, the staff shall be justified to evict the supervisors with the children from the premises.

The operator reserves the right to change the rules at any time.

These rules shall come into effect on the date of their publication.
